

## **Online Privacy Notice**

### **Scope and Consent**

This Privacy Notice describes Aryanss's collection, use, disclosure, retention, and protection of your personal information. It applies to any Aryanss site where this Privacy Notice appears in the footer, and to any Aryanss application, service, or tool (collectively "Services") where this Privacy Notice is referenced, regardless of how you access or use them, including through mobile devices. By using its Services and/or registering for an account with it, you are accepting the terms of this Privacy Notice and Aryanss's User Agreement, and you are consenting to its collection, use, disclosure, retention, and protection of your personal information as described in this Privacy Notice. If you do not provide the information Aryanss require, it may not be able to provide all of our Services to you
